The Mississippi Highway Patrol is honored to have been sanctioned by the National Rifle Association to conduct the 2025 National Police Shooting Championships.

The Championships will take place at the NPSC Home Range at the Mississippi Law Enforcement Officer's Training Academy in Pearl, Mississippi.

While other host locations around the country may run special Postal Tournaments as part of the NPSC Postal Program, NPSC National Champions for all matches will be determined using scores fired at the NPSC home range here in Pearl during this Tournament.

The same is true for NPSC National Records.

And make sure you register for the **Philip Hemphill Magnolia Classic Memorial Regional** being held on September 18th and 19th to get even more range time and practice before NPSC.

Governing Rules: Current NRA Police Pistol Combat Rules will govern throughout the Tournament. The NRA Police Pistol Combat Rule Book is available on-line at ppc.nra.org or use your smart phone camera to scan this Quick Reader Code. If viewing on your PC, press the CTRL Key and click your cursor on it to go to the website.



Registration: Advanced Registration is **highly recommended** and is the only means to ensure you will be able to compete.

To Register: Complete the Registration Form on the last page and follow the submission instructions. You can Register on site for any openings that may be available beginning on Saturday September 20th in the Statistical Office.

All payments will be taken on site and **MUST be in CASH or CHECK**. Please help out by bringing exact change. Make checks out to the MHP Pistol Team.

First Time at NPSC ? - If you have never fired in an NRA National Police Shooting Championships, make sure you check the First Time Shooter box in the Special Award Eligibility section on the Registration Form.

Individual Eligibility: Open to any eligible law enforcement member as outlined in Police Pistol Combat Rule Section 2.4. These include active and retired Law Enforcement Officers, and full time Police Firearms Instructors, Transit Police, Penal Institution Guards, Industrial Police which includes Bank Guards and Armored and Express Company Guards, and Military Police. Federal Flight Deck Officers who hold valid certifications are also eligible.

NRA Membership is not required for any NRA competitions but is encouraged. A special law enforcement discount form for NRA Membership and Renewal will be available at check in.

Match Fees: *Match Fees will be collected at Check In and MUST be paid with Cash or Check*

- NPSC Package Rate: \$ 240. This covers all Championship Matches EXCEPT Team Matches.

If you choose not to do the NPSC Package Rate the Individual Match Fees are:

- Duty Gun Championship Matches: \$ 30
- Distinguished Championship Matches: \$ 30
- Open Class Championship Matches: \$ 45
- Championship Team Matches: \$ 10 per Team Member

- The first Match each day starts promptly at 0800. Shooters are expected to be on the firing line and ready for tower instructions 10 minutes prior to the start time for each event. Please make sure to give yourself adequate time to get your gear together and be on-line when called. There are no refunds for missing an assigned relay.
- All subsequent Matches will begin when the Match before ends, and any necessary Range Operations are completed.
- Matches will run straight through the day. We will monitor the matches and work in a lunch period when possible.
- Combined Relays: Since shooters can only fire one of the three Off Duty Championships and all three matches use the same Course of Fire, Off Duty Matches 15R, 15S and 15DO will be run concurrently in a Combined Relay.

Saturday ~ September 20th

Sunday ~ September 21st

- ♦ Practice Relays:

Practice Relays will be offered on Sunday September 21st to allow competitors to zero their firearms for our elevation and lighting conditions and accustom shooters to the target and barricade system. Start times are approximate and subject to change. All shooters are expected to be on the firing line and ready for tower instructions 10 minutes prior to the start time for each event. There will be no refunds for missing or being late for a Relay.

Practice Relay Tickets are \$ 20.⁰⁰ and allow you to fire an unlimited number of relays.

- Tickets will only be sold on site in the Statistical Office beginning at 1000, Saturday, September 20th.
- There are **NO** assigned target lanes.
- Shooters will be provided one B-27 Cardboard Target Backer and two Repair Centers per relay ticket to be used as they decide.



- Shooters **MUST BRING THEIR OWN STAPLE GUN** or Spray Glue for the Repair Centers
- The first Practice Relay will begin at 0900.
- The final Practice Relay information and start times will be posted on site.

Competitor Check In: Competitor Packets will be available for pick up **on Sunday, September 21st after 1000 am** in the Statistical Office. Competitors will need to present their:

- Current or Retired Law Enforcement or Military Credentials showing eligibility.
- Current Classification Card or current Temporary Classification Book unless you have not fired in a PPC Tournament before.

Once eligibility is determined, you will get your Competitor Packet which will have your Match and Relay Schedule.

Classification: Competitors will be entered using their current NRA Police Pistol Combat Classification of High Master, Master, Expert, Sharpshooter, Marksman, or Classified. Competitors with expired Classifications and new shooters with no Classification or those without a Temporary Record Score Book will fire in the High Master Class as required by PPC Rule 19.2.

You can check your current NRA Classification at LEcompetitions.nra.org or by using your smart phone camera to scan this Quick Reader Code or press the CTRL Key and click your cursor on it.



In Aggregate Match 22 and 19, which are comprised of both revolver and semi-automatic pistol events, competitors will be Classified according to Police Pistol Combat Rule 19.16 pertaining to Team Classifications.

Higher Classification Request: Officers may request to compete in a higher Classification than they are currently Classed. This request must be made in the Statistical Office prior to your first official fired shot. Keep in mind; should you make this request, you will remain in this Class for the entire Tournament, including team matches.

Categories: Municipal, County, State, Federal, Private and Military Police.

Special Categories: Reserve Officer, Conservation Officer, Retired, Retired Over 61, Sheriff/Deputy Sheriff, Female Competitor, and First Time Ever NPSC Shooter.

Team Matches & Eligibility:

- Team Matches will be fired at the conclusion of the individual matches each day.
- Teams will consist of two or four firing members and a Team Captain. The Team Captain may be a competing member of the team.
- Police Pistol Combat Rule 2.8 requires that all team members must be from the same agency. Membership can include officers retired from the agency if they are not now employed by another eligible agency.
- Eligible Military competitors who are also regular full time law enforcement, industrial law enforcement, or reserve/auxiliary law enforcement must sign up with other members from their law enforcement agency.
- **No “pick-up” teams are allowed.**
- Team Classifications will be done following PPC Rule 19.16
- Agencies MAY enter more than one Four Officer or Two Officer Team in each Team Match offered. However, team members may not be on a Four Officer and a Two Officer Team in the same type Match. For instance, a competitor may not be a member of a Four Officer Open Class Revolver Team and a member of the agencies Two Officer Open Class Revolver Team.

Squadding: All matches will be squadded by the Statistical Office.

Shooting Mats/Ground Cloths: Shooting mats for are the responsibility of the competitor.

Eye and Ear Protection: Mandatory for all shooters !

Safety Violations: All firearm safety rules will be strictly enforced, so be sure that your firearm is pointed in a safe direction at all times while on and off the firing line. Any of the following safety violations may result in disqualification from a match. An accumulation of two such safety violations in any single match requires automatic disqualification from that Match and may result in disqualification from the Tournament.

- Pointing an unloaded or loaded firearm up range, or at another person anywhere on the property.
- Dropping of an unloaded firearm. Dropping a loaded firearm is an automatic Disqualification, - PPC Rule 9.21.2.
- Leaving the firing line with a loaded firearm.
- Picking up a dropped firearm, except under the direction of a Tournament Official.
- Any accidental discharge. This does not include rounds fired down range over the established time limit, but does include discharges while loading or clearing a firearm or anywhere else on the property.
- Any other action which the Tournament Director finds to be unsafe or incompetent gun handling, which in any way poses a potential danger or that evidences a reckless or negligent disregard for commonly recognized safety practices. Muzzling anyone, an accidental discharge, having a loaded pistol off range, and other unsafe actions

Firearm Cleaning & Dry Firing: Competitors are reminded that they are responsible for the safe handling of all firearms at all times. Any unsafe act may be grounds for Match or Tournament Disqualification at the discretion of the Tournament Director.

On Range: NO pistol may be out of its holster unless directed by a Tournament Official or Range Control.

Off Range: This includes parking lots, all areas of the property, inside shooter tents, vehicles and trailers, and all other areas. When moving firearms to or from cases, range bags, from holster to case, or vehicle storage areas, all firearms must remain unloaded, the muzzle must be pointed down at all times, and the utmost caution used when servicing, handling, or cleaning firearms.

Awards Ceremony: There will be informal Individual and Team Award Ceremonies conducted on the range for the National Champions once Bulletins are final and match firing allows. NPSC Award Medallions will be available for distribution after each Match Challenge Period ends in the Awards Office inside the Mississippi Highway Patrol Range Building.

NRA Award Schedule: In addition to any awards that may be presented by the Mississippi Highway Patrol Pistol Team, the NRA Law Enforcement Division is sponsoring the below recognition awards.

1. **NPSC Awards:** Custom designed National Rifle Association Award Medallions and acrylic trophies are used for NPSC Awards. Some matches have additional awards or Honorary Awards, such as the Justin Hurst Memorial Trophy for the High Conservation Officer in Match 22.
2. **Final Results Bulletin:** Awards are issued based on the Statistical Offices' Final Results Bulletin for each Championship Match.
3. **Individual Match Awards:**

Special Awards: The following special awards will be presented.

- Craig J. Miller Memorial Trophy: Framed Photo Award for High Federal Officer in Match 22.
- Walter Weaver Memorial NYPD Honorary Trophy: Framed Photo Award for High Municipal Officer in Match 22.
- Justin Hurst Memorial Honorary Trophy: Framed Photo Award for the High Conservation Officer in Match 22.
- National Border Patrol Honorary Trophy: Framed Photo Award for the High Overall Shooter in Match 22.

4. Team Match Awards:

Matches 30, 31, 32, 33, 36, 37, 38, 39, 40, & 41, 42 & 43: First, Second & Third Place Overall Teams = Acrylic Trophies for Firing Members

5. Distinguished Points: Distinguished Award Points are awarded from NRA Headquarters after the completion of NPSC following the provisions for the NRA Distinguished Revolver, Semi-Automatic Pistol, and Production Pistol Program contained in the NRA Police Pistol Combat Rules.

6. President's Match: In addition to the NRA Award Trophies listed in the Award Schedule, the Top Fifteen Percent of all U.S. Competitors will be issued a President's Medallion. Please note that the NRA Law Enforcement Assistance Committee added the Distinguished Production Pistol to the President's Match Aggregate in November of 2024.

7. Trophy Award Procedures and Award Hierarchy: A competitor or team will not receive a First, Second, or Third place Award and a Class, Category or Special Category Award in the same event. The Award will be passed on to the next highest scoring competitor unless there are no other eligible shooters for the Award.

Order of Trophy Awards:

- Place
- Class
- Category
- Special Category

8. International Shooters: (Non U.S. citizen) can only win NPSC Open Class 3000 Championship title Match 22 provided that the International Shooter's country has a matching championship match, and a U.S. citizen can win their police championship. It is the International Shooters responsibility to bring documentation proving these requirements.

9. **NRA Firearm Certificates:** Even though this event is a Postal Tournament and not conducted by the NRA, the NRA is providing several Firearm Award Certificates to augment the MHP Pistol Team's awards.

Since these Firearm Award Certificates are being provided by the NRA and not the MHP Pistol Team, **recipients must provide a completed Internal Revenue Service W-9 Taxpayer ID Form prior to receiving the Firearm Award Certificate.**

Award Limits: Following NPSC tradition, and policy established by the Law Enforcement Assistance Committee, competitors are limited in the number of NRA Firearms Awards they can receive given the number and type of matches fired. In the case of the MHP Pistol Team Postal NPSC Tournament, competitors may only be awarded a total of two NRA Firearm Award Certificates, one from Firearm Award Group One Matches and one from the Firearm Award Group Two Matches.

- Firearm Award Group One Matches include:
 - Open Class Aggregate Match 22,
 - Open Class Semi-Automatic Pistol Aggregate Match 13,
 - Open Class Revolver Aggregate Match 6, and
 - Open Class Duty Optic Pistol Match 13DO.
- Firearm Award Group Two Matches include;
 - Production Pistol Match 23,
 - Production Duty Optic Match 25,
 - Stock Service Semi-Automatic Pistol Match 14, and
 - Stock Service Revolver Match 7.

If by fired score a competitor is "scheduled" to be issued a Firearm Award Certificate but has already been awarded one for a match within the same Firearm Award Group, since they can only be awarded one Firearm Award Certificate, the award will be passed down to the next eligible competitor. Example: the same competitor places first overall in Match 22 and is also first place in Match 13. Since these matches are both in Firearm Award Group One, the competitor can only receive one Firearm Award Certificate. Following the Match Hierarchy below, they will be issued a Firearm Award Certificate for Match 22 and the Firearm Award Certificate scheduled for the winner of Match 13 will be passed down to the next eligible competitor in Match 13.

Match Hierarchy: The following Match hierarchy will be used in assigning Firearm Awards Certificates within the Groups.

- Firearm Award Group One: Match 22, Match 13, Match 6, then Match 13DO.
- Firearm Award Group Two: Match 23, Match 14, Match 25, then Match 7.

Firearm Award Certificate Schedule:

- Match 22: First Place and First Time NPSC New Shooter
- Match 13: First Place and First Time NPSC New Shooter
- Match 6: First Place and First Time NPSC New Shooter
- Match 13DO: First Place and First Time NPSC New Shooter
- Match 23: First Place and First Time NPSC New Shooter
- Match 14: First Place and First Time NPSC New Shooter
- Match 25: First Place and First Time NPSC New Shooter
- Match 7: First Place and First Time NPSC New Shooter



Targets: Official NRA B-27 targets will be used.

Scorecards: Each competitor will receive an Individual Scorecard Book in their Competitor Packet. A \$5 fee will be charged for replacement books. Please report to the Statistical Office for replacement scorecards.

Scoring: Competitor scoring will be utilized. This means that competitors are responsible for recording all shots and tallying the total scores. Pursuant to PPC Rule 14.2, **NO** competitor will score their own target **NOR** may a competitor score the targets of a competitor from their same agency. If this cannot be avoided due to the Relay's makeup contact a Match Official to score the targets.

Scorers will only record the number of hits in each scoring value area and misses on the scorecards. The Statistical Office will compute the final value of the hits and combined score. So be sure to check the scored hits closely **BEFORE** you sign your scorecard and then the preliminary match bulletins !

Please remember that PPC Rules prohibit the use of plug-type scoring gauges. Overlays and Eagle Eyes may be used by competitors.

It is the competitor's responsibility to ensure that their scorecards are completed, signed and turned into the collecting Match Official. Once the scorecard is signed, the value of shots recorded on the card is final and cannot be changed.

Competitors who submit incomplete scorecards will be Disqualified for part or all of that match. Scores will be extended and totaled by Statistical Office personnel. Be sure to check the preliminary match bulletins!

All scoring by competitors MUST be done using a pencil.

Result Bulletins: Preliminary and Final Bulletins will be posted outside on the covered bulletin boards near the Statistical Office.

Refires: Will not be allowed for defective guns, holsters, ammunition or for other malfunctions of the shooter's equipment. Competitors may clear jams or malfunctions provided all safety requirements are met. See PPC Rule Section 9 for more information.

National Records: If a competitor feels that they have fired a National Record, they must take their targets and firearm to the Referee Tent to have the firearm inspected, trigger weighed, and score verified. Otherwise, the National Record will not count.

Breaking of Ties: Ties will be broken following the below listed steps, and then by use of PPC Rule Section 15.3, except that no shoot offs will occur.

- **Open Class Division Matches:** Unbreakable ties will be broken by the last match fired in the Aggregate. Match 6 Example: A tie in Match 6 would be broken by checking the Match 5 scores, if still tied then the Match 4 scores will be used. If still tied, Match 3 scores would be checked and then other prior matches if needed.
- **Off Duty Sidearms, Stock Service Revolver, Stock Service Semi-Automatic Pistol, Production Pistol, Production Duty Optic Pistol, Distinguished Revolver, Distinguished Semi-Automatic Pistol and Distinguished Production Pistol matches:** Ties will be broken following PPC Rule 15.3.1 a-f. If a tie still exists, the first match in the Tournament in which the competitors fired will be used for score comparison for the process in PPC Rule 15.3.1 a-f. If a tie still exists, the next match fired by the competitors will be used and the process repeated as necessary.

- **President's Match:** Unbreakable ties in the President's Match will be broken by the Distinguished Semi-Automatic Pistol Match score and then, if necessary, the Distinguished Revolver Match score. If the tie still exists, scores from the first Match in the Tournament in which the competitors fired will be used. If necessary, the process will be continued.

If the Tie is unbreakable after following all steps, the Tournament Director and Statistical Officer will use the following process.

- The scorecards of the shooters involved will be placed face down on a table. If the scorecard has marking on the back that may identify the shooter or team, the shooter names or team names can be written on blank pieces of paper. Then a randomly selected competitor, that is not from the same agency as the shooters involved, will be asked to select one of the facedown scorecards. The shooter of the selected scorecard will win the tie. If multiple shooters are involved in the tie, the drawing process will continue with shooters ranked as their scorecard is drawn. The shooters involved are not required to be present.

Challenges: A Challenge fee of \$3.00 will be charged for each target challenged. See NRA Rule Section 16.1 for the Challenge procedures.

- Challenges of Preliminary Bulletin scores must be made within one hour of posting time. Once a Bulletin goes Final, scores cannot be changed even if there is an error.
- The decision of the Scoring Referee is final.
- Posted Score Challenge Period: The Challenge Period extends for a minimum of one hour after the Preliminary Bulletin is posted on the Official Bulletin Board or as directed by the Statistical Officer. The Challenge Period may be extended overnight for the last match of the day. The expiration time for the Challenge Period for a particular match will be posted at the same time as the Preliminary Bulletin for that match. It is the competitor's responsibility to check Preliminary Bulletins prior to the expiration of the Challenge Period. No Challenges will be accepted, and no corrections will be made to the Bulletin after the expiration of the Challenge Period.

Protest: A Competitor may ONLY Protest:

- Any injustice which the competitor feels has been done except the evaluation of a target.
- The conditions under which another competitor has been permitted to fire.
- The equipment which another competitor has been permitted to use.
- Team Matches: Team members who desire to file a Protest must state their facts to the Team Captain who must make the official Protest.
- A three-member Protest Committee will be established by the Tournament Director as needed.

To Protest: Make a verbal Protest to the Chief Range Officer or the Chief Statistical Officer stating which of the four conditions listed above your Protest is about.

- If you meet the Protest eligibility, they will attempt to resolve your Protest.
- If not resolved you MUST go to the Chief Referee, request the NPSC Protest Form, and complete and submit it following the instructions on the form.
- The Protest fee is \$10.00.
- The decision of the National Police Shooting Championships Protest Committee shall be final.

Courses of Fire: The Range Officer will announce the course of fire, shooting positions and time prior to the start of each Match and Stage. Time will start with a loaded gun in holster. No part of the competitor's hand may touch the gun or holster until the command to commence firing is given.

All loading will be with cartridges taken from the competitor's pocket, cartridge belt, mechanical loaders, or special pouch. To force reloading under time constraints, magazine loading is limited to 6 rounds per magazine. There is no limit on the number of magazines you have but all used during the firing of a stage or string **MUST** be on your person. It is the competitors' responsibility to have sufficient ammunition in their possession to complete the Match being fired.

A conventional right or left-hand holster must be used. For safety reasons, shoulder, cross draw or holsters which require releasing by insertion of finger within the trigger guard will not be allowed. A holster cannot be tied down.

Optical Devices: No optical devices other than normal glasses worn for corrective eyesight or Sunglasses will be permitted on the range during Match firing for use by competitors. Use of a mechanical iris, eye patch or eye cover is also prohibited.

Firearms & Ammunition Allowed: Competitors are responsible for ensuring their firearms, equipment and ammunition meet the requirements in NRA Police Pistol Combat Rule Book Section 3, or applicable Police Pistol Combat Bulletin.

If a competitor is uncertain about any equipment being eligible, they must contact the NRA in advance or see an NRA Referee on site for a decision prior to firing the first Match with the firearm or equipment.

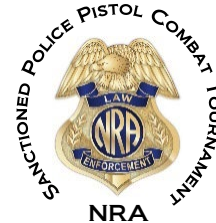

- **Production Pistol, Distinguished Production Pistol, Production Duty Optic Pistols & Off Duty Production Pistol:** Shooters must ensure their pistol and iron sights are listed as Approved in PPC Bulletins 14-1 and 16-1.

The NRA has made it clear that NO matter what APPROVED Replacement Sight is used, the sights MUST keep a Duty Gun Point of Aim/Point of Impact, NOT a competition set up, such as a Neck Hold, Shoulder Hold, or Head Hold. A Duty Gun Point of Aim/Point of Impact sight set up requires the sights to be aligned on the X Ring/Center Mass to obtain a Hit in the X Ring/Center Mass area.

Duty Optics for Production Pistols and Open Class Duty Optic Pistols: Any optic used must be listed as Approved in Police Pistol at
