*Registered Competitors will receive the 2015 National Police Shooting Championships Tournament Program Book in the Competitor Package during on-site check in. The NPSC Tournament Program Book serves as the official program during the Championships and overrides any this announcement where changes are made.*



## National Police Shooting Championships



*Well it is once again time for the annual National Police Shooting Championships and we invite you to join us for days of shooting challenges, lots of fun and a chance to meet fantastic law enforcement professionals from all over the United States and international shooting team members.*

*The Championships are open to public and private law enforcement members and select law enforcement members of the U.S. military. This is not an Invitational Only Match, there is no Point Series that you have to gain to be allowed to come, no lottery slots you have to try for, and no club slot you have to be selected for. Everyone is welcome to come to the National Police Shooting Championships whether you just shoot one match and come just for the day, or shoot all of the matches and join us for the entire event, NPSC Banquet and Awards Ceremony.*

*And no, you do not have to be a High Master shooter to attend or do well at the Championships. In fact High Masters and Masters make up the smallest group of shooters who attend the Championships, and like all Police Pistol Combat matches you will be competing against those shooters in your own skill classification level. You can even shoot as an Unclassified Shooter if you have never fired in a NRA Police Pistol Combat match or hold no PPC Classification.*

*This year there are several changes that are based on direction from the NRA Law Enforcement Assistance Committee and competitor suggestions. These include;*

- *The reduction of the length of the National Police Shooting Championships by one day. The NPSC will conclude at the end of the banquet on Wednesday night. Team Matches will be fired Monday-Wednesday. This will hopefully increase the participation in the Team Matches, and allow more people to attend the NPSC in general by reducing their total time and expenses such as food, hotel, and ammunition.*
- *To preserve all of the revolver matches, competitors will have the choice to fire either a revolver or semi-automatic pistol in the match they select. This includes the Open Class Division Championship and Stock Service Duty Gun Championship and their related Team Championships.*
- *So competitors can continue to work towards earning their Distinguished Semi-Automatic Pistol and Distinguished Revolver Badges, both matches are being offered to all shooters with the chance to earn the prestigious President's Championship Medallion if you fire in both Championships. Competitors who want to be considered*

*for the Service Handgun Aggregate Championship and NPSC Grand Championship Aggregate will no longer be required to fire the Distinguished Championship matches.*

- *With the passage by the NRA Board of Directors of PPC Rule 17.5.1, as requested by the NRA Law Enforcement Assistance Committee, non-fired team matches cannot be conducted as part of the National Police Shooting Championships. As such the World Team Matches have to be retired. However the Awards Schedule will continue for High International Shooters within Individual and Team Championship matches as before.*
- *To give competitors who come to NPSC without anyone else from their agency or are at NPSC with other agency members but not firing a Championship Team Match with their agency members because they are the “odd person out” we are offering special non-sanctioned Invitational Two Officer Non-Championship Team matches under the provisions of PPC Rule 1.8.4. These Pick-Up Team Matches will be fired at the same time as the regular Championship Team Matches so that NO additional range time is required. See the Championship Team Match section for more details.*

*We also have a new NPSC Host Hotel. It is the Embassy Suites Hotel & Spa. As part of the NPSC package they will provide a complementary reception most nights with beverages and light snacks, free internet access, free breakfast. The hotel also has a full restaurant, lounge bar, fitness center, business office, coffee shop café, gift shop newsstand, game room, and indoor pool.*

*And don't forget to take advantage of the tuition free armorer school offerings by signing up for a slot and the seminars covering the Law Enforcement Officers Safety Act (LEOSA). For those notified they received a slot for an armorer's course, they will take place on Saturday September 19<sup>th</sup> at the NPSC Host Hotel. The LEOSA seminar will also be on Saturday at the Host Hotel and run from 1400 to 1600. It will be held again on Sunday from 0900 to 1200. No registration is required for the LEOSA seminars, just go to the Ocotillo I Room at the hotel.*

*We look forward to seeing you in Albuquerque for the Championships, so you can meet new friends, see beautiful New Mexico, and have a ton of fun.*

## ***OTHER ACTIVITIES***

- ❑ **FREE Armorer Schools:** There are several tuition-free armorer schools scheduled, including Glock, Smith & Wesson, Double Star (AR Platform) and SIG Sauer that will be held in conjunction with the National Police Shooting Championships.

## Special Championship Packages

### First Time NPSC Shooters

**First Time NPSC Option 1** – This firing package is **FREE** First Time NPSC Shooters and registers you to fire your choice of the **Stock Service Semi-Automatic Pistol Championship**, **or** the **Production Semi-Automatic Pistol Championship** on Monday September 21<sup>st</sup> **and** the **NPSC Law Enforcement Shotgun Championship** anytime the shotgun range is open. Remington shotguns are available for your use and Remington ammunition is provided free while supplies last. You may sign up for additional matches using the Individual Match registration option if you wish.

**First Time NPSC Option 2** – Register for the First Time NPSC Shooter Package for \$130.00, which is \$90 off the regular rate, and shoot in **any or all** of the NPSC Championship Handgun and Shotgun Matches.

Shooters who register as First Time NPSC Shooters MUST report to the Statistical Office when they arrive to confirm their First Time NPSC Shooter Status.

## ***NPSC Alumni Shooters***

**Early Registration Championship Package - \$165.00:** Sign up by Wednesday August 26<sup>th</sup> and **save \$ 60** over the Standard Championship Package. This package makes you eligible to fire in all of the Championship Matches and may save you in match fees even if you do not fire all the matches. This Package is only **available until Wednesday August 26<sup>th</sup>**.

**Championship Package - \$195.00:** For a flat fee you are eligible to fire in all of the Championship Matches and **save \$25** over the regular individual fees. This package may save you in match fees even if you do not fire all the matches. This Package is **only available from August 27<sup>th</sup> until 5:00 p.m. Eastern Standard Time on Thursday September 3<sup>rd</sup>**.

**Late Registration Package - \$215.00:** For a flat fee you are eligible to fire in all of the Championship Matches. This Package applies from **September 4<sup>th</sup> on and must be done on-site at the Statistical Office.**

## ***Championship Team Matches***

**Championship Team Composition:** Police Pistol Combat Rule 2.8 requires that all Championships team members must be from the same agency. No "pick-up" teams are allowed. Membership can include officers retired from the agency if they are not now employed by another eligible agency. Eligible Military competitors who are also regular full time law enforcement, industrial law enforcement, or reserve/auxiliary law enforcement must sign up with other members from their law enforcement agency.

**Exception:** This year we are offering special non-sanctioned Invitational two officer team matches under the provisions of PPC Rule 1.8.4. These are called ***Pick-Up Team Matches*** and are only for competitors who are at NPSC without anyone else from their agency or at NPSC with other agency members but not firing a Team Championship match with their agency members they are the "odd person out". An example is where an agency has three officers attending NPSC. The Team Captain signs the best two shooters up for the Stock Semi-Automatic Pistol Two Officer Team Championship which leaves their third agency member unable to shoot in the Team Championship. The "odd person out" can sign up for the same match under

the Pick-Up Team Category and shoot the team match with another competitor in the same circumstances.

Pick-Up Teams will fire at the same time as the regular Two Officer Team Relays **so as not to use any additional range time**. For instance, Pick-Up Team competitors firing the Two Officer Open Class Revolver Pick-Up Team Match will fire on the same relay as those firing the Open Class Revolver Two Officer Team Championship.

Invitational Pick-Up Team Matches are not Championship Matches. Pick-Up Team scores are not eligible for National Records, scores are not used for Classification, and there will be a limited Awards Schedule.

Competitors who sign up under the Pick-Up Team Category will be matched by the Statistical Office with another Pick-Up Team Competitor. Pick-Up Team Competitors need to report to the Statistical Office to see who they have been squadded with and get their Invitational Pick-Up Team Card 30 minutes prior to their Relay.

**Cost:** \$15 per Pick-Up Team Competitor.

**Invitational Pick-Up Team Matches Offered:** Open Class Division Revolver Two Officer Pick-Up Team Match, Stock Service Semi-Automatic Pistol & Revolver Two Officer Pick-Up Team Match, and Production Semi-Automatic Pistol Two Officer Pick-Up Team Match.

**Championship Team Match Sign Up/ Fees:** Team sign up will be done in the Statistical Office beginning on Sunday September 20<sup>th</sup>. Two Officer Team Matches are \$30.00 per team and Four Officer Team Matches are \$50.00 per team.

The cut off time for Team sign up is 60 minutes prior to the firing of the individual match used for the applicable team match score. Once the first shot has been fired, team member substitutions cannot be made nor any refunds given.

**Number of Teams:** Departments MAY enter more than one Four Officer or Two Officer Team in each match type. However, team members may not be on a Four Officer and a Two Officer Team in the same in match type. For instance, a competitor may not be a member of a Four Officer Open Class Revolver Team and a member of the agencies Two Officer Open Class Revolver Team.

**Team Member Firing Order:** So that all team shooters can have the opportunity to have a coach when firing, half of the team will shoot and the second half may coach and then they will switch off when the course is complete. For instance, for a Four Officer Team, two officers will be shooting while two others coach. When the course is done, Range Control will direct the team to remove the fired targets and post two new targets for the second half of the team to fire on.

**Target Lanes:** Target lanes will not be assigned. Four Officer Teams will pick TWO open target lanes on the LFFT side of the range and post two targets to start. Two Officer Teams will pick ONE open target lane on the RIGHT side of the range and post one target to start.

## ***Available Team Matches***

### ◆ **OPEN CLASS DIVISION TEAM CHAMPIONSHIPS**

**Firearms:** All team members must use the same type firearm for the Match being fired. I.E., all fire Open Class Revolvers or all fire Open Class Semi-Automatic Pistols.

**Course of Fire:** The National Police Course. The description can be found under Match 5 & 12 for the Open Class Division Championships on Tuesday's schedule page.

#### **Four Officer Teams can chose to fire either;**

Match 30: Four Officer Open Class Revolver Team Championship

**OR**

Match 32: Four Officer Open Class Semi-Automatic Pistol Team Championship

#### **Two Officer Teams can chose to fire either;**

Match 31: Two Officer Open Class Revolver Team Championship

Match 33: Two Officer Open Class Semi-Automatic Pistol Team Championship

## ◆ PRODUCTION SEMI-AUTOMATIC PISTOL TEAM CHAMPIONSHIP

**Firearms:** All team members must fire Production Semi-Automatic Pistols.

**Course of Fire:** Duty Gun Division Course of Fire. The description can be found under the Stock Duty Dun Championships on Monday's schedule page.

## ◆ WORLD TEAM CHAMPIONSHIPS

The Two and Four Officer World Team Matches have been Non-Fired Paper Matches at the National Police Shooting Championships since 2009. The change to non-fired matches was made by the NRA Law Enforcement Assistance Committee due to the fact that there was insufficient time to run the fired matches, historically only three teams fire, and the Championship Team Awards Ceremonies were delayed each year while waiting for the three teams to shoot, Preliminary Results published and for Challenge Periods to end.

On December 6, 2014, the NRA Law Enforcement Assistance Committee recommended the adoption of Police Pistol Combat Rule 17.5.1 to

require Team Matches offered at the National Police Shooting Championships be fired matches. The new Rule was then adopted by the NRA Board of Directors on January 10, 2015 and added to the PPC Rules.

The same conditions that led the World Team Match to becoming a Non-Fired Paper Match in 2009 still exist. Since PPC Rule 17.5.1 prohibits non-fired matches from being offered the World Team Matches can no longer be part of the NPSC Tournament and are being retired.

The Awards Schedule will continue for High International Shooters within Individual and Team Championship matches.

## ***HOW TO REGISTER FOR INDIVIDUAL MATCHES***

- ❑ **PDF Form Fill Registration:** Open the NPSC Form Fill Registration that is on the ***NPSC Home Page*** and *Save As* to your computer with your last name in the file name. Then complete the registration, save it again and then e-mail it to [LEcompetitions@nrahq.org](mailto:LEcompetitions@nrahq.org). You will be sent a response e-mail to let you know we received it. If you want to pay by check, print and mail in your registration with your check.
- ❑ **On Line:** When ready, the on line registration will be posted at the ***NPSC Home Page***. It will be listed on the top left menu when active and remain available until 1700 Eastern Standard Time on Monday September 3<sup>rd</sup>. After that time registration can be made on-site.

**On Line Payment Options:** In addition to using your personal or agency credit card to register on-line you may select payment by Agency or Personal Check. Just register on line and make your payment in the Statistical Office when you check in.

## ***NPSC FACILITIES***

The City of Albuquerque and the Albuquerque Police Department are our host for the National Police Shooting Championships. They have been great supporters of the program and our competitors since we came to Albuquerque. The quality of today's NPSC would not be possible without their dedicated support.

The NRA National Police Shooting Championships are at Shooting Range Park operated by the City of Albuquerque. NPSC utilizes a dedicated 100 plus point firing line specifically designed for use by NPSC.

**DIRECTIONS:** Shooting Range Park is located at 16001 Shooting Range Road, approximately 12 miles west of the intersection of I-25 and I-40. It is easy to reach by traveling west on I-40 and exiting at Atrisco Vista Boulevard (formally Paseo del Vulcan), Exit 149. Turn right at the stop sign and proceed north four miles; turn left onto Shooting Range Road and travel three miles to the Park.

Competitors are responsible for ensuring that their firearm, ammunition and equipment are compliant with the current NRA Police Pistol Combat Rule Book. Any equipment which may be questionable should be submitted for review by NRA Law Enforcement Staff prior to or during NPSC.

The 2015 Edition of the Police Pistol Combat Rules will govern this event. The Firearms and Ammunition requirements contained in the PPC Rule Book are outlined below. The complete PPC Rule Book and updates are available on-line at <http://ppc.nra.org> under **PPC Rule Information** on the Law Enforcement Competition pages.

Once a Match has started, no changing of firearms is allowed except under the provisions of PPC Rule Section 9.3.

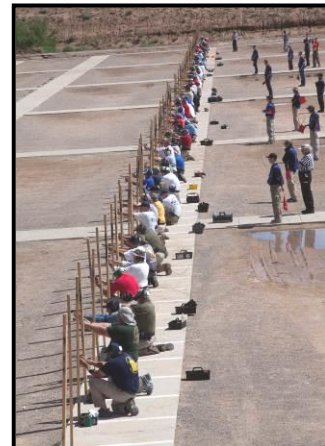
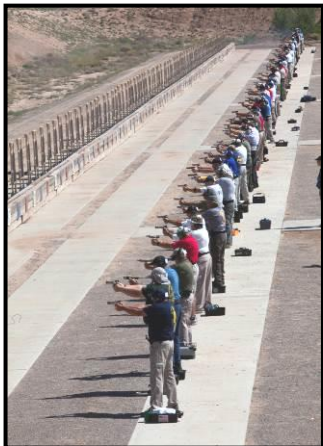

## **THE NEW MEXICO CHALLENGE**

**Saturday September 19<sup>th</sup>**

This is a free non-tournament event conducted by NRA Law Enforcement Competitions to **expose law enforcement and security professionals from New Mexico agencies who do not have a permanent PPC Classification** to the NRA Police Pistol Combat program and the National Police Shooting Championships. **Alumni shooters are welcome to shoot and can have a PPC Classification.+**

Officers will be run through the PPC Stock Semi-Automatic Course of Fire and since it is a non-tournament event they will not have to compete against experienced PPC shooters. Previous New Mexico Challenge shooters may enter the Alumni Special Category even if they have a PPC Classification but cannot win overall trophies, prizes or firearm awards.

Rules are simple: officers only need their duty handgun, holster, magazines, and 50 rounds of ammunition. No need for duty ammunition, inexpensive practice, or training ammo is fine.

We will have trophy awards for top shooters and law enforcement category awards, such as Municipal, County, State, Federal, and Security.

**Team Event:** Challenge officers from your rival Squad, Division, Unit, District, or your best friends. There will be un-fired team matches for Two and Four Officer Teams. Just tell us before you shoot who your teammate is and we will combine your individual scores to get your team score.

## ***NPSC PRACTICE DAY***

**Date:** Sunday, September 20, 2015

**Location:** NPSC Police Pistol Combat Range

**Cost:** \$ 8 Per Relay Ticket

**Relays Offered:** There are three types of relays held on NPSC Practice Day.

- **Match 5 Relay:** Range Control will run the 60 round NRA National Police Course of Fire. This will allow competitors to practice at the 7, 15, 25 and 50 yard line as if under match conditions.
- **Match 4 Relay:** Range Control will run Match 4, the 25 yard Standing Without Support Course of Fire.
- **Zeroing Relay:** At 25 yards, Range Control will allow competitors to fire the number of rounds they choose during the time allotted to fire. Shooters will then be allowed to inspect their target and after all shooters have returned from downrange, allowed to handle their unloaded handgun and make any necessary sight adjustments. Another firing period will then be provided, repeating the process. Shooters will then move to the 50 yard line and the process repeated to check/adjust 50 yard sight zeros.
- **Relay Format:** While each relay follows a set course and time limits, shooters may practice whatever stage and fire whatever number of rounds they desire as long as they follow all range commands. For instance, during the Match 4 Relay, instead of firing strings of 12 rounds standing off hand at 25 yards, you could practice left hand barricade or during Zeroing Relays you may practice whatever stages you desire during the open fire period.
- **Multiple Guns:** You may fire/zero multiple guns during the Practice Day. As always, **guns must be cased or holstered**. Just check with Practice Day Range Officers on how, and when you may switch firearms.

**Practice Day Ticket Raffle:** A Practice Day Ticket Raffle will be conducted consisting of donated merchandise. To be eligible for the Practice Day Prize Drawing, competitors must place one of their shooter labels on their Practice Day Ticket or print their name on the back of the ticket and drop it in in the Practice Day Raffle Drawing Box in the Statistical office. The names of the winners of the Practice Day Raffle Prize Drawing will be posted outside the NPSC Awards Office on Tuesday afternoon September 22<sup>nd</sup>.

## REMINGTON LAW ENFORCEMENT SHOTGUN CHAMPIONSHIP BEGINS

**0900 to 1630**

The Law Enforcement Shotgun Championship Match relays begin on Sunday. You may fire this match on Sunday, Monday, Tuesday, or Wednesday (last relay will be at 1500). Simply register in the Statistical Office and report to the Shotgun Range during operating hours. Relays are formed as shooters arrive at the range.

**Firearm:** Competitors may use a Model 870 or Model 1187 Shotgun provided at no charge by Remington Law Enforcement, or furnish their own shotgun.

Shotgun must be factory manufactured, 12 gauge, barrel length not to exceed 22 1/4 inches, metallic sights only, and no modifications. Barrel is to be cylinder or improved cylinder bore; constriction at the choke may not exceed 0.0149. No back boring is allowed. Interchangeable chokes are allowed. Shotgun barrels will be checked for choke and inspected.

All safety devices provided by the manufacturer must function as designed.

**Slings:** Shotgun may be equipped with a sling but it cannot have sling cuffs or other devices that attach to the arm. **Sling may only be used during Stage 4.**

**Sights:** Metallic / Fiber Optic duty sights only.

**Ammunition:** Competitors can use **ammunition provided by Remington Law Enforcement at no charge** (as long as supplies last) or by competitor. Ammunition must be 12-gauge, 00 lead Buckshot with nine pellets per shell, and 1 ounce rifled slugs. Ammunition will be inspected and a sample shell may be required for disassembly and examination. It is best if you bring the original box the rounds came in with you. Reloaded or sabot ammunition is not allowed.

**Shotgun Carry:** Shotguns brought to and from the range **MUST** be:

- Unloaded with the action open and Safety ON
- Cased or Uncased
- Carried **muzzle down** whenever uncased.

**Target:** NRA B-27. Each shooter will have 6 targets posted. Four are for the Buck Shot stages, one is for the 25 yard slug stage and the last is for the 50 yard slug stage.

**Scoring:** Competitor scoring will be used.

**Scoring Values:**

- Buckshot: Each hit within the 7 Ring and in are worth 5 Points. Hits outside the 7 Ring are zero.
- Slugs: Hits are scored using the B-27 target X, 10, 9, 8, and 7 Point face value scoring rings.

**Tie Breaking:** See Appendix Section D of the NRA Police Pistol Combat Rule Book.

**Course of Fire:** National Police Shooting Championships Shotgun Match, as follows:

**Stage 1:** At 15 yards fired from the hip or shoulder at Target Numbers 1 through 4.

Fire 5 rounds of 12 gauge nine pellet 00 Buckshot at four B-27 targets within 10 seconds.

Fire one round at three of the targets and two rounds at one target of your choice.

Gun stock must be held under the arm until targets start to turn. Gun may then be brought to the shoulder, or fired from the underarm position.

**Stage 2:** At 20 yards fired from the shoulder at Target Numbers 1 through 4.

Fire 5 rounds of 12 gauge nine pellet 00 Buckshot at four B-27 targets within 5 seconds.

Fire one round at three of the targets and two rounds at one target of choice.

Gun may be placed against the shoulder before targets start to turn.

**Stage 3:** At 25 yards fired from the shoulder at the target numbered 25. Fire 5 rounds of rifled slug at one B-27 target within 10 seconds. Gun must be held under the arm until targets start to turn.

**Stage 4:** At 50 yards fired from the shoulder in either the kneeling or standing position at the target numbered 50. Fire 5 rounds of rifled slug at one B-27 target within 60 seconds. Do NOT use the target you already fired slugs at. Gun stock must be held under the arm until targets start to turn. Sling may be used but it cannot be wrapped around the arm, or otherwise attached in any manner to your body until after the targets start to turn.

NPSC individual and Team Championship Matches Begin***

**Target Used:** All matches will use the NRA B-27 Target.

**Approved Firearms:** See the Approved Firearm and Ammunition Matrix in the previous section of this Announcement.

**Trigger Pulls Will be Checked:** Make sure you test the triggers pull on **ALL** of your firearms to make sure they comply with the requirements in Section 3 of the Police Pistol Combat Rule Book. The weights are also listed in the Approved Firearm and Ammunition Matrix in the previous section of this Announcement. The only firearms without a trigger pull requirement are Stock Service Revolvers and Off Duty Revolvers as you are not allowed to use them in single action mode.

Be sure to **use a fixed weight Trigger Pull Weight set** when checking your triggers. Electronic Trigger Pull Units are often inaccurate and/or inconsistent. **The number one reason firearms are disallowed is because they do not hold the required trigger weight. Just because it held a weight last month or at last year's NPSC does not mean it will hold it during the referee's Inspection this year.**

**Holsters:** PPC Rule 3.14. A conventional right or left-handed holster must be used. For safety reasons, shoulder, cross draw, or holsters which require releasing by insertion of finger within the trigger guard will not be allowed. Semi-Automatic pistol holsters must completely cover the trigger.

**Ground Cloth:** Only the provided NPSC shooting mat ground cloth may be used. Shooting mats may only be used at the 50 yard line. NO external, or internal knee pads may be used. This includes those incorporated into pants.

Semi-Automatic pistol holsters must completely cover the trigger.

**Assigned Relay Numbers and Start Times:** To help shooters plan their day we use assigned Relay Numbers and Relay Times for each match except the Law Enforcement Shotgun Championship Match.

Final Relay Start Times, the number of Relays, and Relay Numbers will not be determined until registrations for each Match are determined and may change during the Tournament because late on-site registrations, re-fires, weather, or other issues. So **make sure** you pay attention to any relay announcements made over the public address system and **check NPSC**

**Bulletin Board** and exit doors of the NPSC buildings when you arrive each day and before you leave each day for the most current Relay Start Times.

The relay number format is based on the Match being fired and the Relay number within that match. The first one or two numbers are the Match Number and the last number is the Assigned Relay for that match.

Examples:

- Relay 133 is Match 13, the Open Class Semi-Automatic Pistol 1500 Match, and is for the 3<sup>rd</sup> relay of that Match.

**Stage 3:** 15 yards – Double action, 12 shots, one or two hands, from standing without support position, 20 seconds, includes reloading for second 6-shot string.

**Stage 4:** 25 yards – Double action, 18 shots, one or two hands, 6 shots kneeling, using the barricade for cover and support, 6 shots standing left hand from behind barricade and 6 shots standing right hand from behind the barricade, 90 seconds, time starts with loaded gun in holster and includes reloading for subsequent 6-shot strings. The barricade **MUST** be used for cover and support.

When using the barricade the body cannot pass the fault line that extends from the base of the barricade up range towards the shooter.

**Individual Stock Duty Gun Championships:** Competitors have the option to fire **either** Match 14, the Stock Service Semi-Automatic Pistol Championship Match **or** Match 7, the Stock Service Revolver Championship Match.

## ◆ OPEN CLASS DIVISION MATCHES

In each of the Open Class Matches competitors have the option to fire **either** their Open Class Semi-Automatic Pistol **or** their Open Class Revolver. As in the past, each Championship Match will have a National Champion and full Awards schedule.

In Team Matches, Team Captains need to decide if their team will fire the Open Class Semi-Automatic Pistol Team Match **OR** the Open Class Revolver Team Match with all members firing the same firearm type and register for the appropriate Four or Two Officer Team Match. Four Officer Teams will fire on the left side of the range & Two Officer Teams will fire on the right side of the range.

Agencies MAY enter more than one Four Officer or Two Officer Team in each Match Type. However, team members may not be on a Four Officer and a Two Officer Team in the same in Match Type. For instance, a competitor may not be a member of a Four Officer Open Class Revolver Team and a member of the agencies Two Officer Open Class Revolver Team.

Competitors may not fire in more than one Relay or Match.

### **Individual & Team Matches in this Division fired today will be;**

- Open Class Revolver – Matches 1 thru 6
- Open Class Semi-Automatic Pistol – Matches 8 thru 13
- Open Class Revolver Four Officer Team – Match 30

**Course of Fire:** The Open Class Division courses of fire are in Rule Book Section 7 as Matches 1 thru 6 and 8 thru 13 for the **Individual Matches** for a total of 150 rounds and possible score of 1500 points. **Team Matches** use the National Police Course of Fire, a 60 round course, which is the same as Match 5 and Match 12. The Team Matches have a total possible score of 600 points per shooter.

**Match 1 & 8:** 24 Shots, Standing Without Support at 7 and 15 Yards. Two stages of 12 shots each fired double action standing without support. Stage 1 fired at 7 yards and Stage 2 fired at 15 yards. 20 seconds per stage starting with loaded gun in holster and

**Match 2 & 9:** 18 Shots, Kneeling, and Standing at 25 Yards. 6 shots kneeling; 6 shots left hand standing with support; 6 shots right hand standing with support; all firing double action. Time is 90 seconds for the entire course, starting with loaded gun in holster and including time to reload.

**Match 3 & 10:** 24 Shots, Sitting, Prone, and Standing at 50 Yards. 6 shots sitting; 6 shots prone; 12 shots standing with support (6 shots left hand, 6 shots right hand); all shooting single or double action. Time is 2 minutes and 45 seconds starting with loaded gun in holster and including time to reload.

**Match 4 & 11:** 24 Shots, Standing Without Support at 25 Yards. 2 stages of 12 shots each fired double action, standing without support at 25 yards. Time is 35 seconds for each 12-shot stage starting with loaded gun in holster and including time to reload.

**Match 5 & 12: NRA National Police Course** – 60 Shots

**Stage 1:** At 7 yards, 12 shots double action from the standing without support position. Time limit is 20 seconds, including time to reload.

**Stage 2:** At 25 yards, 6 shots double action from the kneeling position; 6 shots standing with support, left hand; 6 shots standing with support, right hand. Time limit is 90 seconds including time to reload.



**Stage 3:** At 50 yards, 6 shots single or double action sitting; 6 shots prone; 6 shots standing left hand from behind barricade; 6 shots standing right hand from behind barricade. Time limit is 2 minutes and 45 seconds, including time to reload.

**Stage 4:** At 25 yards, 6 shots double action standing without support. Time limit is 12 seconds. No barricade or other support is used.

**Match 6 & 13:** Open Class Division 1500 Aggregate

This is an unfired aggregate of each competitor's score in Matches 1 thru 5 or 8 thru 12. The Match 6 score determines the Open Class Revolver Champion and the Match 13 score determines the Open Class Semi-Automatic Pistol Champion.

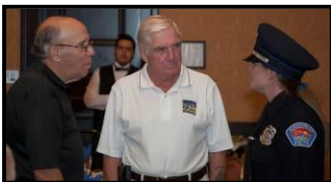

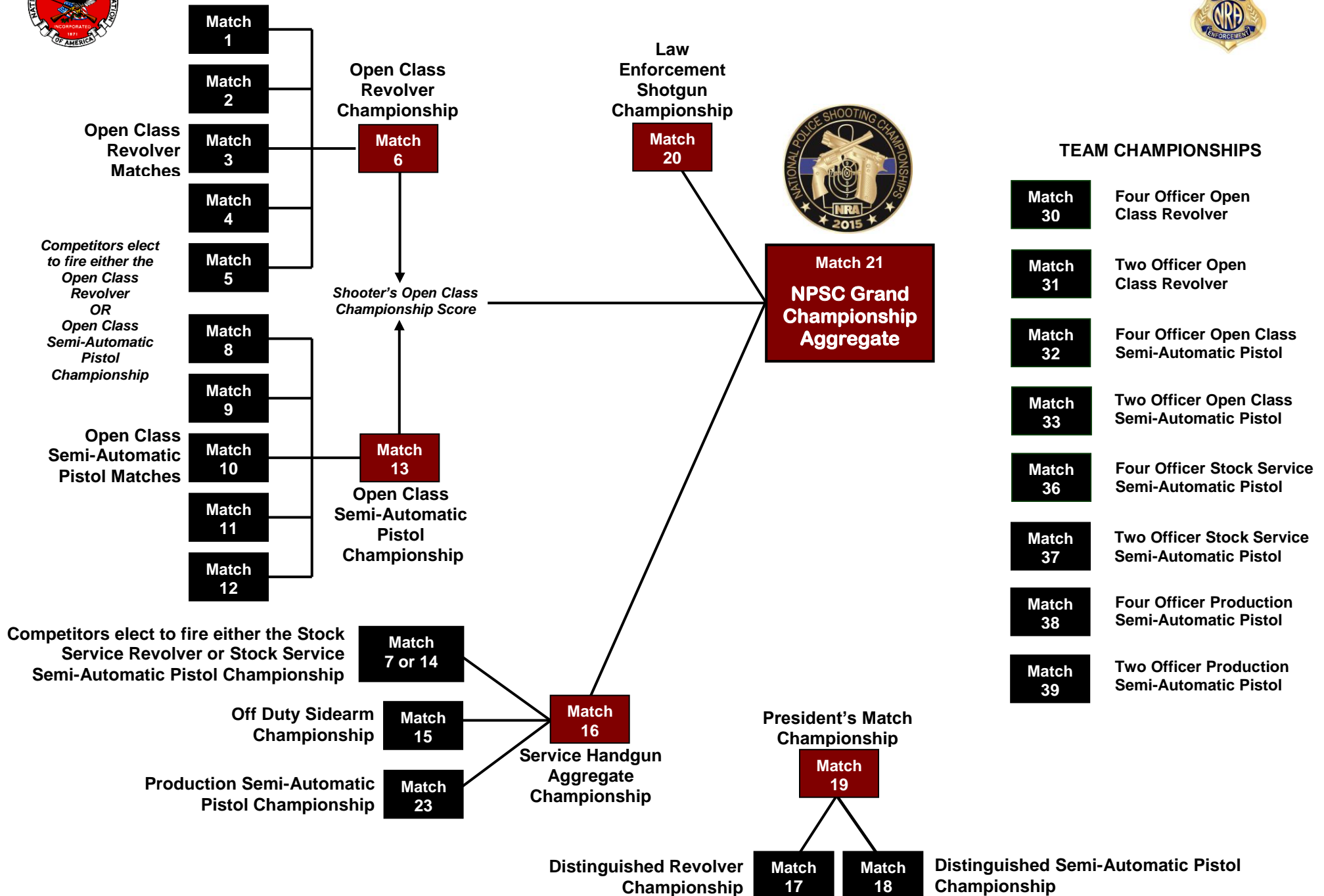
