

# APPLICATION TO CONDUCT AN NRA POLICE REVOLVER DISTINGUISHED MATCH

Application to conduct an NRA Police Revolver Distinguished Match as part of the \_\_\_\_\_  
NRA Police Pistol Regional.

1. If accepted for NRA registration, we, the sponsoring organization, request authority to include, in our Regional program, an NRA Revolver Distinguished Match which will afford competitors an opportunity to compete for credits toward the NRA Revolver Distinguished Badge. In order to ensure the successful administration and execution of such a competition, we agree to conduct the match in accordance with current NRA Police Pistol Combat Rules as follows:

A. The revolver must be capable of chambering and firing the standard 158 grain lead .38 special service load. It must be a factory manufactured revolver with no external modification, except for stocks which may be modified or changed because of the size of a competitor's hand or to facilitate loading. Except as provided for above, with respect to stocks, and the honing of the sear or sear notch in the hammer to make a more crisp trigger pull and smooth the action and/or to maintain the required two and one-half pounds minimum trigger pull, no external or internal modifications may be made to the revolver as manufactured and sold by the factory of origin, no parts may be removed from the revolver, either externally or internally nor may any be added. *Modifications made for safety reasons by the factory of original manufacture or by a competent gunsmith according to factory specifications, to a revolver which had previously been approved as a "Police Service Revolver" will not make such a revolver illegal under the provisions of this section. However, alterations not made or approved by the factory of original manufacture will move the revolver so altered into the illegal category.* **NOTE:** This portion of Rule 3.1 is not intended nor does it alter the rules with respect to sigh blackening.

Any pistol or revolver which incorporates a manufacturers' design or design change after October 15, 1974 must be submitted to the NRA Law Enforcement Assistance Committee for approval.

1. **Trigger** – must have single and double action capability and must be capable of lifting two and one-half pounds when the gun is cocked for single action firing. Triggers will be weighed. Any trigger, sold by the manufacturer of the revolver, without modification may be used.
2. **Sights-** fixed or adjustable rear sights may be used. Adjustable front sights are not permitted.

3. **Barrel** - length not to exceed 6 inches.

4. **The following are not allowed:** trigger shoes, any external trigger stop device, use of any filler substance to make the front of the trigger smooth, filing or otherwise removing the ridges on the trigger, filing or otherwise reducing the trigger width or length, tape on stocks, thumb rests or stocks flared at the base, any substance which results in a sticky surface to the stock or hand, installing crane or yoke locks, pinning the barrel or Smith and Wesson "L" frame guns installing internal trigger stops, installing adjustable hammer struts, and deleting safety bars. Specifically prohibited is any system of recoil control based on compensators, barrel venting or barrel porting.

B. **Ammunition must be furnished by the competitor.** It must be from a licensed manufacturer, new issue, caliber .38 special, 158 grain lead service ammunition. Reloaded ammunition will not be allowed. Either round nose or semi-wadcutter service ammunition may be used. Ammunition will be inspected by the Referee.

C. The NRA Police Revolver Distinguished match will be fired on the NRA B-27 Target. No other target may be substituted.

2. The NRA Revolver Distinguished match will be the 60-round NRA National Police Course, fired as a separate match, outdoors.

3. Within ten (10) days of the conclusion of the competition submit official NRA Revolver Distinguished score cards (SR-114) to NRA.

4. A basic entry fee of \$1.00 per competitor will be charged and remitted to the NRA.

5. Make every effort to ensure that every competitor is eligible, using regulations and directions provided by NRA. **No person may fire this match for practice.**

**Entry of Distinguished competitors may be restricted if range capacity has been reached, in which case no Distinguished personnel would be permitted to compete.**
