

*Start Position:* Loaded Duty Handgun secured in holster. Rifle Loaded to Cruiser Safe (Safety ON, Bolt Closed on Empty Chamber, Loaded Magazine Locked in Place) secured in gun case in trunk. Shooter seat belted in cruiser with hands at 10 & 2 on steering wheel.

Course Description: While parked doing paperwork you come under attack.

On Start Signal bail from cruiser and engage immediate Threat Targets 1 thru 3 with your Duty Handgun from Firing Area 1. Move to the trunk, retrieve your Patrol Rifle from case and engage Threat Targets 4 thru 7 from within Firing Area 2. Withdraw to safety by moving from cover-to-cover and engage Threat Targets 8 & 9 from Fining Area 3, Threat Targets 10 through 12 from Firing Area 4 and Threat Targets 13 through 17 from Firing Area 5.
