# Jimmy Hazen Memorial Shooting Tournament

Sponsored by Tallahassee Law Enforcement Competitions and Sanctioned  
by the NRA Law Enforcement Division



**What:** We are conducting a Sanctioned NRA Police Pistol Combat Tournament and running the NRA Stock Service Semi-Automatic Pistol course of fire.

These Tournaments are a great way for you to evaluate your skill level, identify needed training areas, and practice your handgun skills to keep you prepared for the ever-increasing dangers you face on the street and off duty.

You do NOT need any fancy gear or guns to start shooting these matches. Just a stock duty gun, holster, three magazines with magazine pouch, hearing protection and protective eyewear.

No special invitation, prior training or rule class is required, and there is nothing to memorize ahead of time. The course will be announced as you shoot just like the stages during a qualification or training shoot and fellow shooters will gladly help you out. All you have to do is follow the range commands and standard safety rules and have a great time shooting.

**Time:** Range opens at 9:30 am / Match starts at 10:00 am

**Rules:** NRA Law Enforcement Competitions Duty Gun Division Police Pistol Combat Rules will be used. Firearm specifications are in Section 3.7. The NRA Police Pistol Combat Rule Book is available on-line at [ppc.nra.org](http://ppc.nra.org).

**Match Fired:** The 48 round NRA Law Enforcement Division Stock Service Semi-Automatic Pistol Match 14 will be fired using the NRA Law Enforcement B-27 target.

**Course of Fire:** To force reloading under time restraints all magazines are only loaded with six rounds. Start position is standing with holstered loaded handgun and arms at sides.

Stage 1: 3 yards - 6 shots one hand standing without support in 8 seconds.

Stage 2: 7 yards - 12 shots, one or two hands standing without support in 20 seconds which includes reloading for second 6 shot string.

Stage 3: 15 yards - 12 shots, one or two hands standing without support in 20 seconds, includes reloading for second 6 shot string.

Stage 4: 25 yards - 18 shots, one or two hands; 6 shots kneeling from behind the barricade for cover and support; 6 shots standing left handed using barricade cover from behind the left side; and 6 shots standing right handed using the barricade for cover and support from the right side. Time limit is 90 which includes required reloads.

**Eligibility:** Law Enforcement officers and private security officers covered in PPC Rule 2.4 through 2.6 may compete in the regular Law Enforcement category. Civilian shooters are also welcomed and are eligible for Civilian Class Awards but their scores will not be submitted to NRA Law Enforcement Competitions.

**Entry Fee:** \$ 20.00 per competitor. Registration will take place at the WSCO Training Center on the day of the Tournament day beginning at 9:30 am. Please arrive early to register.

**Awards:** Awards will be given based on the final scores at the end of the Tournament.

**Results:** Final Tournament results will be posted at the WSCO Training Center after all final tabulation.
