**RULES:** Unless otherwise stated herein or by the Match Director's bulletin the NRA Police Pistol rules will govern these matches. (Competitors are responsible for being familiar with these rules).

WHEN CALLING PLEASE LEAVE YOUR NAME, CLASSIFICATION, DATE AND EVENTS YOU WISH TO SHOOT AND RELAY CHOICE. PLEASE SQUADD EARLY. RANGE SPACE IS LIMITED.

REGISTRATION FEE: \$10.00. Individual match fees (1500 - Service Gun - Speed Challenge - Semi Auto Match) \$10.00 EACH, Plus Registration Fee. Team Match \$5.00 each team member.

**CLASSIFICATION** NRA rule 19-1. Classification cards must be presented at registration. (High Master, Master, Expert, Sharpshooter, Marksman, Classified, Unclassified). Civilians will be allowed to compete. Anyone without a valid card **MUST compete in the HIGH MASTER Class.** For AWARD PURPOSES ONLY, if there are 8 or more Unclassified competitors, an Unclassified Class will be formed for Awards. Shooters may not use an Open Revolver classification to shoot in an open Semi auto Class and vise visor. The same rule applies to the stock service revolvers and semi autos pistol. Competitors may request to compete in a higher classification than they are currently classed. This request must be made in the Statistical Officer prior to your first official fired shot. Keep in mind; should you make this request, you will remain in that class for the entire games (including team match designations.) If there are any questions on classifications please e-mail or call and I'll explain.

**AWARDS**: Top gun awards, **PLAQUES** will be awarded to 1st, 2nd & 3rd place. Top Gun Awards to be determined by a combined score of the first 1500, first service gun and speed challenge events. All other winners will receive medals. Class awards, 1st place in each Class. 2nd place if 6 or more. Individual awards if seven or more in each class. Service Gun Awards, Semi Auto Match Awards and the Speed Challenge Awards will be determined by the Lewis System. Class award winners are not eligible for individual awards. Top gun awards winners are not eligible for Class or individual awards.

**TARGETS:** Targets for all matches will be the B-27E targets. **SCORING:** All scoring will be done on line by competitors.

#### NOTE

THIS EVENT IS A NYS DISTINGUISHED EVENT. COMPETITORS WHO COMPETE IN THE SERVICE GUN MATCH AND THE SEMI AUTO, 60 ROUND MATCH WILL BE ELIGIBLE. THIS IS A NON FIRED MATCH. PLEASE SEE RULES CONCERNING THE NYPCA DISTINGUISHED PROGRAM

**TEAM ENTRY:** Two person teams are allowed for the 1500, service gun, and speed challenge matches. Teams must be declared at sign in, prior to the first relay. Team members must be from the same Agency/Department. Civilian teams are allowed. Civilians, however, may not combine with LE to form teams.

All team matches are non-fired matches. Scores from the first service gun match will be used for the service gun team. Scores from Match #5 of the first 1500 will be used for the 1500 team, and scores from the first speed challenge match will be used for the speed challenge team.

#### **SERVICE GUN & SPEED CHALLENGE EVENTS**

**FIREARM ALLOWED - SERVICE REVOLVER** A revolver capable of chambering and firing standard 158-grain lead, .38 special service load. It must be a factory-manufactured revolver, with no external modifications, except for grips/stocks, which may be modified or changed because of the size of a competitor's hand or to facilitate loading. No internal modifications may be made that would render the revolver less safe than originally designed by the manufacturer. Specifically prohibited is any system of recoil based on compensators, barrel venting, barrel porting or weighted grips or grip panels.

- a. Trigger Must have single and double action capability.
- b. Sights Fixed or adjustable rear sight. Adjustable front sight is not authorized. Front sights must be a ramp or post as sold by the original manufacturer of the firearm.
- c. Barrel Length not to exceed four inches.

**AMMUNITION** the competitor will furnish all ammunition. Either hand loaded or factory loaded ammunition, .38 special, 158-grain lead service, round nose, semi-wad cutter, or hollow point is authorized. **NO WADCUTTER!** No refire will be allowed for defective guns, ammunition or other malfunctions of the shooter's equipment.

**FIREARM ALLOWED - SEMI-AUTOMATIC SERVICE PISTOL**: Factory manufactured (catalog item) center-fire semi-automatic pistol of .35 caliber or larger, barrel length not to exceed 5 inches (replacement barrels cannot be longer than the original). Any accessories, parts and components, which are manufactured to duplicate, in materials and dimensions, the original, as offered by any of the manufacturers of the pistol, will be accepted. Open sights, from any manufacturer, are acceptable. Rear sights may be fixed or adjustable and fixed open front sights may not extend beyond the front of the slide maximum sight radius not more than 7-1/2 inches. Trigger pull not less than 3.5 pounds single action or for those of double action capability only.

The pistol must be equipped with standard issue or commercially procured grips/stocks of the same size and design. Finger groove and slip on grips are allowed. Stocks may be modified or changed because of the size of the competitor's hand. Thumb rest grips/stocks or those flared at the base are not allowed nor tape on the grips/stocks or any substance which results in a sticky surface to the grips/stocks or hand.

No external modifications are permitted. No internal modifications may be made that would render the pistol less safe than originally designed by the manufacturer. All safety features of the pistol must operate properly. Specifically prohibited are full-length Bo-Mar type ribs on the slide, trigger shoes, any system of recoil control based on compensators, barrel venting, barrel porting or weighted grips or grip panels.

Each competitor is responsible for his/her firearm and any which may be questionable should be submitted to the sport coordinator prior to the match for a decision.

**AMMUNITION:** Reloaded or factory lead, ball, jacketed soft point, semi-wad cutter, or hollow point ammunition is allowed. Ammunition must be loaded to equal the energy of factory service ammunition. Magazines will be loaded with six rounds only for this match.

#### SERVICE GUN COURSE OF FIRE:

48 rounds. All times start with loaded firearm in holster.

**Stage1**: 3 yds...double action 6 shots in 8 seconds one hand (strong), from the standing unsupported position.

Stage 2: 7 yds... double action, 12 shots from standing unsupported position, 20 seconds, includes reload

#### Targets will be scored and changed after stage 2

**Stage 3**: 15 yds. double action, 12 shots from standing unsupported position, 20 seconds.

**Stage 4**: 25 yds. double action, 6 shots kneeling strong hand using the barricade, 6 shots standing left hand barricade, 6 shots right hand barricade, includes reloading, 90 sec

#### SPEED CHALLENGE EVENT

48 rounds - All times start with loaded gun in the holster. Shooter may start with hand on weapon.

**FIREARM ALLOWED:** See Service Revolver and Semi-Automatic Pistol requirements. Either of these two weapons may be used in this event. **NO PPC GUNS** 

**AMMUNITION:** the competitor will furnish all ammunition. Either hand loaded or factory loaded ammunition, .35 caliber or larger may be used, round nose, semi-wad cutter, or hollow point may be used. **NO WADCUTTER!** No high speed or magnum ammunition will be allowed. All ammunition must be loaded for and produce sufficient velocity to pass through the target and backer. Shots that do not pass through the target and the backer will be scored as misses.

#### **COURSE OF FIRE SPEED CHALLENGE:**

**Stage1** - Seven yards - 12 rounds. Standing without support, fired in two 6 round strings of 5 seconds per string. (Reloading is not timed)

**Stage 2 -** Fifteen yards - 12 rounds. Standing without support, fired in two 6 round strings of 6 seconds per string. (Reloading is not timed)

#### Targets will be scored and changed after stage 2.

**Stage 3** - Twenty-five yards - 12 rounds. Standing either left or right hand barricade, fired in two 6 shot strings of 8 seconds per string. (Reloading is not timed)

**Stage 4** - Twenty-five yards - 12 rounds. Standing either left or right hand barricade, 20 seconds. Time to include reloading for subsequent 6 shot string.
