The National Police Shooting Championships, known by many as NPSC, or Police Nationals, is a three-day international shooting championship that attracts law enforcement officers and armed security professionals representing local, state, and federal agencies from across the United States and from numerous countries around the world.

As part of the annual Championships, we host a Law Enforcement Equipment Exposition so that law enforcement agency representatives and our law enforcement competitors can meet local and national law enforcement equipment and firearm manufacturers, distributors, and dealers to see or purchase their latest products.



Vendors of all types of law enforcement related products and services can meet representatives from the state's law enforcement agencies, ranging from Chiefs and Sheriffs, to ranking administrators, to procurement officers, tactical team officers, firearm instructors, and those who recommend or approve law enforcement product purchases within their agency.

The new host of the NRA National Police Shooting Championships is the Mississippi Department of Public Safety. They are building new facilities for the Championships located at the Mississippi Highway Patrol Firearms Training Facility, which is co-located at the Mississippi Law Enforcement Officers Training Academy in Pearl, Mississippi just outside of the City of Jackson.



While the new Exposition Hall will not be completed in time for this year's Championships, they have made special arrangements to host the annual NPSC Law Enforcement Equipment Exposition at the Academy so we can continue the tradition of having law enforcement product vendors on-site to interact with our competitors.



While our program Supporting Partners sponsors receive priority for booth spaces, we offer a number of spaces to other vendors. General Exhibitor Information

- The Exhibit Hall and Competitor Break Area will be at the Academy building, a short walk from the main NPSC Range. This will allow competitors to visit with vendors throughout the day.
- Expo Hours: Monday & Tuesday = 10:00 am to 4:30 pm Wednesday = 10:00 am to 2:00 pm
Vendors can set their own booth hours and if necessary can arrive for set up while the show is already underway, or leave the show early to accommodate business needs. Vendors can also invite current and potential customers to the show for business meetings with no special pass needed for show entry.
- Vendor Set Up: You can set up as early as noon on Sunday September 22nd.
- Booths are approximately 8 x 10 feet with pipe and drape and include a display table with tablecloth and chairs. Electrical service is available at many booths using vendor provided extension cords.
- Direct sales ARE allowed and ENCOURAGED – so bring product to sell as competitors are eager to buy and take something home!
- Vendors will be offered complimentary tickets to the Championship Awards Dinner Banquet on Wednesday September 25th at the NPSC Host Hotel.
- An advanced mailing will be done to area law enforcement agencies inviting their administrators, purchasing agents, and other non-competitors to the Exposition to see your products first hand.
