

National Police Shooting Championships Postal Program Information & Application



The NPSC Postal Component: Because of the pressures on law enforcement budgets, the super inflated cost for food, hotel stays, and the incredible increases in fuel cost, many Police Pistol Combat competitors cannot travel to Mississippi for the National Police Shooting Championships. So in 2022 a separate Postal component was added to the NPSC Program to allow competitors to fire NPSC Matches at their local range during a given date range with their scores becoming part of a National Postal Results Bulletin. This allows PPC competitors to be part of the Championships and compare their match scores to other shooters from across the county. While part of the NPSC Program, Postal scores <u>are not</u> used to determine the NPSC National Champions but do establish National Postal Winners.

NPSC National Champion Determinations: Only scores fired at the NPSC Tournament held in Pearl, Mississippi conducted by the Mississippi Highway Patrol Pistol Team and the NRA are used to establish the National Champions and are the only scores eligible for NPSC Records. This ensures competitors fire using the same target system, and under the same range control, temperature, wind, humidity and light conditions.

Applicant Requirements: Any organization with an Outdoor PPC Range that has a Turning Target System can apply to participate in the NPSC Postal Program. Just complete the Tournament Application section on Page 3 and 4 and e-mail it in. **Registered, Regional and State Championship Tournaments that have already been approved to be conducted during the NPSC Postal Date Range are automatically part of the 2024 NPSC Postal Program.**

Tournament & Matches Dates: Tournaments participating in the NPSC Postal Program must be held between August 23rd and October 7th, 2024, in order to take place during the same general time frame as the Championships in Pearl, Mississippi. This provides 45 days for conducting Matches. Tournaments can:

- Be just one day long,
- Run on multiple consecutive days, such as running three Matches on Saturday, September 21st, and two Matches on Sunday, September 22nd, or,
- Be run on multiple days within a set Tournament Date Range. For instance, the Revolver Matches are scheduled for Saturday, August 24th and the Semi-Automatic Matches scheduled two weeks later on Saturday, September 7th. Any days from August 23rd to October 7th may be used for your Tournament Date Range.

Tournament Fees: There are <u>no additional fees</u> for adding a Tournament to the NPSC Postal Program. The regular Tournament Fees for Registered, Regional and State Championship Tournaments apply with Tournament Fees reported using the regular Tournament Fee Report.

Matches Conducted: You can apply to conduct all of the Individual and 2 Officer Team Matches normally fired at the Championships or select <u>any combination</u> of the Matches you want to run. As always, Distinguished Matches can only be run at Regional and State Championship Tournaments. Team Matches must be stand-alone <u>Fired</u> Matches.

Combined Relays: To save range time and accommodate your shooters you can fire several different matches in one relay. For instance, you have 10 target lanes and there are three shooters who want to fire Open Class Revolver Match 6, four shooters who want to fire Open Class Semi-Automatic Pistol Match 13 and one shooter who wants to fire Open Class Duty Optic Pistol Match 13DO. Because all three matches use the same Course of Fire you can have all the shooters fire on the same relay instead of running three relays. If you don't have enough Target Lanes for the number of shooters, using two

Combined Relays will still save you significant time. The same applies to the Duty Gun Matches. Since all use the same Course of Fire, shooters on Combined Duty Gun Relays can be firing the Stock Service Revolver Match, Stock Service Semi-Automatic Pistol Match, Production Pistol Match, Production Duty Optic Match, Off Duty Revolver Match, Off Duty Semi-Automatic Pistol Match or Off Duty Production Duty Optic Match.

When running Combined Relays you may want to have revolver shooters use the left side of the range and Semi-Automatic shooters use lanes to the right of the revolver shooters to avoid the possibility of revolver shooters being distracted by ejecting brass from the semi-autos.

Registration & Statistical Operations: These are done just as you would for any of your regular Tournaments. No coordination or special reporting to NRA Law Enforcement Competitions is required.

NPSC Postal Program Award Trophies: Since there are no NPSC Postal Program Fees there are no Award Trophies provided to local participating Tournaments. If you are running a Regional as part of the NPSC Postal Program you will receive the normal Regional Medallions and Award Trophies for your Regional.

Tournament Application Options: You can use the NPSC Postal Application on page 3 to;

- Apply to run a new <u>Registered Tournament</u> to have it be part of the 2024 NPSC Postal Program.
- Apply to conduct a new <u>Regional Tournament or State Championship</u> and have it be part of the 2024 NPSC Postal Program.
- If you have Turning Targets and have an Approved Tournament already Sanctioned you can apply to have it changed to a Registered Tournament so it can be part of the 2024 NPSC Postal Program.
- Remember, if you already have a Registered, Regional, or State Championship Tournament approved to held between August 23rd and October 7th, 2024, scores submitted by the NPSC Postal Program cutoff date will automatically be added to the NPSC Postal Program National Results Bulletin.

Score Reporting: Scores are submitted as usual by sending in SR-500 Police Pistol Combat Tournament Score Reports or using the electronic PC-to-PC Score Report system. To be part of the NPSC Postal Program National Results Bulletin, scores must be received by midnight on Tuesday, October 21st, 2024. If fired, Distinguished Production Pistol scores must be reported by sending in the competitor's NRA Distinguished Production Scorecard.

Competitors Firing in Multiple NPSC Postal Tournaments: Since not all NPSC Postal Tournament locations will offer all of the NPSC Postal Matches, competitors may fire at multiple NPSC Postal Tournament locations so that they can take part in all the Matches they want to. However, if a competitor shoots the same Match at more than one NPSC Postal Tournament location and duplicate Match Scores are received by the NRA, only the <u>first</u> score received for the Match involved will be recorded. If a competitor fired NPSC at Pearl and at a NPSC Postal location, only the NPSC Pearl scores will be counted.
