Governing Rules: Current NRA Police Pistol Combat Rules will govern throughout the Tournament. All competitors are encouraged to review the current PPC rules. The NRA Police Pistol Combat Rule Book is available on-line at ppc.nra.org or scan the QR code with your cell phone camera.



Eligibility: Open to any eligible law enforcement member as outlined in Police Pistol Combat Rule Section 2.4. Identification to support Law Enforcement or Military Police status must be available and shown on demand of a Tournament Official.

Classification: Competitors will be entered using their current NRA Police Pistol Combat Classification of High Master, Master, Expert, Sharpshooter, Marksman, or Classified. Competitors with expired Classifications and new shooters with no Classification or those without a Temporary Record Score Book will fire in the High Master Class as required by PPC Rule 19.2. Competitors may check their current NRA Classification at LEcompetitions.nra.org.



Categories: There will be no categories used in the monthly Registered Tournaments. The Categories found in PPC Rule 2.6 may be used at the Dixie National's Regional Tournament and Alabama State Championship Tournament.

Tournament Fees: *Include NRA Match Fees*

Alabama Governor's Twenty Monthly Registered PPC Tournaments:

- Match Fee \$ 30.00
- League Fee \$ 30.00 This is a onetime per shooting season fee and is charged at your first match only.

Dixie National's Regional and Alabama State Championship PPC Tournaments

- Fees will be posted at a later date.
- League Fee of \$ 30.00 if you have not already paid earlier in the year.

Awards: The Number and Assignment of Awards will depend on competitor numbers and will consist of;

- Cash
- Trophies/Medals
- Certificates
- Door Prizes

Final Result Bulletins: Will be posted and sent to competitors if requested.

Registration: For Onsite Registration please complete the appropriate Competitor Registration Form and bring it with you to the range at least 45 minutes prior to the first match. The Range opens at 8:00 am and the first relay will begin at 9:00 am.

For Pre-Registration please complete either the Alabama Governor's Twenty Monthly Registered Tournament Competitor Registration Form, the Dixie National's Regional Tournament or Alabama State Championship Tournament Competitor Registration Form and follow the instructions on the form for submission.

Range Rules: All competitors will comply with posted range rules and directions from Tournament Officials.

Targets: Official NRA B-27 targets will be used.

Scoring: Competitor scoring will be used. Pursuant to PPC Rule 14.2, **NO** competitor will score their own target **NOR** may a competitor score the targets of a competitor from their same agency. If this cannot be avoided due to the Relay's makeup contact a Tournament Official to score the targets. PPC Rules prohibit the use of plug-type scoring gauges. Overlays and Eagle Eyes may be used by competitors.

Score cards must be signed and are FINAL once signed so **PLEASE** double check the recorded hits and values BEFORE signing.

Challenges: See PPC Rule 16.1 for procedures with a Challenge Fee of \$5.00 for each Challenge made.

Match Times and Relays: Range opens at 8:00 am. The first match will begin at 9:00 am with the rest of the matches beginning at the conclusion of the prior match. The normal match order will be;

- Stock Service Revolver Match 7

- Open Class Division Matches – Fire either Open Class Revolver Matches 1 through 5 or Open Class Semi-Automatic Pistol Matches 8 through 12.
- Combined Relay for Stock Service Semi-Automatic Pistol Match 14 and Production Duty Optic Match 25.
- Dixie National’s Regional and Alabama State Championship Tournament: Distinguished Revolver Match 17, Distinguished Semi-Automatic Pistol Match 18, Distinguished Production Match 24, and Two Officer Team Matches will be added with the Match Order posted at a later date.

Courses of Fire: The Range Tower will announce the course of fire, shooting positions and time prior to the start of each Match and Stage. Time will start with a loaded gun in holster. No part of the competitor's hand may touch the gun or holster until the command to commence firing is given.

All loading will be with cartridges taken from the competitor's pocket, cartridge belt, mechanical loaders, or special pouch. To force reloading under time restraints, magazine loading is limited to 6 rounds per magazine. There is no limit on the number of magazines you have but all used during a the firing of a stage or string **MUST** be on your person.

A conventional right or left-hand holster must be used. For safety reasons, shoulder, cross draw or holsters which require releasing by insertion of finger within the trigger guard will not be allowed. Holster cannot be tied down.

APPLIES TO ALL FIREARMS		Rule 3.1
Each competitor is responsible for their firearm and any which may be questionable should be submitted to the Tournament Director, Referee, or 3-Man Jury for decision prior to being used. All standard safety features of the pistol must operate properly. With respect to Sections 3.2 through 3.10, and in addition to the firearm specific regulations below, the following features are either Allowed or Prohibited on all firearms.

Firearm / Caliber: Approved Pistols for this Division are listed in Police Pistol Combat Bulletin 14.1 on the Law Enforcement Competitions website. To be considered for approval the pistol must be a mass produced center-fire semi-automatic pistol made for police or military use (at least 1,000 pistols), a stock catalog item that is unmodified from its original factory condition, and have a double, double/single, or striker type action. <u>Double/single actions pistols must have a manual decocking device, or equipped with an automatic decocker that returns the pistol to double action mode when the slide is released.</u> All double/single action and double action pistols must fire the first shot of every stage double action.

Sight Radius Maximum		7.5 Inches
Installation of extended magazine releases and slide catches produced by the pistol's manufacturer.		Allowed
Replacement of the factory fixed or adjustable service sights with another service type sight, luminescent service sight, or fiber optic service sight sold by the pistol's manufacturer as a factory catalog replacement part for the pistol, or with an approved sight listed in Police Pistol Combat Bulletin 16.1 on the NRA Law Enforcement Competitions website. Any replacement sights must be listed on the Scorecard with make, model and Approval Number as listed in Police Pistol Combat Bulletin 16-1.

NO matter what APPROVED Replacement Sight is used, the sights MUST keep a Duty Gun Point of Aim/Point of Impact, NOT a competition set up, such as a Neck Hold, Shoulder Hold, or Head Hold. A Duty Gun Point of Aim/Point of Impact sight set up requires the sights to be aligned on the X Ring/Center Mass to obtain a Hit in the X Ring/Center Mass area.

For Distinguished Matches - Prior to shooting, your pistol MUST be INSPECTED and TRIGGER PULL WEIGHED to Certify your pistol as approved.

PRODUCTION DUTY OPTIC PISTOLS		Rule 3.10.1
In addition to the specifications within Section 3.1, and 3.10, the following specifications apply for Production Duty Optic Pistols.		
Firearm / Caliber: Pistols meeting the specifications for Production Pistols in Section 3.10 and are listed as Approved in Police Pistol Combat Bulletin 14.1 may be equipped with an Approved non-magnified optic suitable for duty use.		
The Duty Optic must be listed as Approved by NRA Law Enforcement Competitions in Police Pistol Combat Bulletin 19.1 on the Law Enforcement Competitions website.		
To be considered for approval, Duty Optics must mount <u>without any modification</u> to the handgun as originally manufactured. Swapping the original slide to an aftermarket slide with optic mount cuts is <u>not</u> allowed since the handgun is no longer as originally manufactured.		
The pistol should have co-witnessed front and rear sights, but the rear sight may be removed to mount the Duty Optic or to use a Stock Optic Ready Plate.		
All Other Specifications are the same as Production Pistols
